#### **REPORTS**

that in order to accommodate the roof replacement needed at South Chicago Learning Center and roof hatch replacement at District Office, it is necessary to utilize the services of a design builder; and

that Nia Architects of Chicago, Illinois has been selected as the design-builder from the pre-qualified listing of A/E firms as approved by the Board on August 3, 2006 (#27532) and that the project will be scheduled for completion based on the submittal of the scope of work as planned by the College and District Office staff with the cost of constriction estimated to be approximately \$310,200.00 for the South Chicago Learning Center roof replacement and \$9,995.00 for the District Office roof hatch replacement for a total cost not to exceed \$320,195.00, and

that District Office staff reviewed proposals from the below listed firms for this work in addition to all firms on the pre-qualified list previously approved by the board:

1.	Architects Enterprise	MBE	Chicago, Illinois
2.	Tilton, Kelly + Bell	WBE	Chicago, Illinois
3.	Nia Architects	MBE	Chicago, Illinois

Administrative Services staff have determined that, based on experience and expertise in roof replacement and roof hatch replacement, the design-build cost proposed by Nia Architects Inc. is acceptable and within related design-build standards; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced design-build opportunities and since Nia Architects Inc. is a certified MBE and is a pre-qualified vendor, it has been determined that it is in compliance with the Board approved Participation Plan.

### **RECOMMENDS**

that the Board of Trustees authorizes the Chairman to enter into an agreement with Nia Architects Inc., Chicago, for Design-Build Services for the South Chicago Learning Center roof replacement and District Office roof hatch replacement, for an amount not to exceed \$320,195.00.
