Program Agreement French Pastry School

THE CHANCELLOR

REPORTS

that in Board Report No. 23906 dated July 3, 2003, the Board of Trustees approved a three year training agreement with the French Pastry School (FPS) effective July 7, 2003 to June 30, 2006 to provide classes leading to a Certificate of Pastry Arts and continuing education classes; and

that the above mentioned board report also approved the tuition and fees for the certificate program in the amount of \$13,477 per student in which FPS pays CCC \$1,773 per student for the certificate program, and \$105 per student in continuing education program; and

that in Board Report No. 23948 dated August 7, 2003 the Board of Trustees approved an amendment Board Report No. 23906 dated July 3, 2003 to reflect the correct amount of \$1,605 that FPS would pay CCC; and

that Board Report No. 26916 dated September 8, 2005 approved the increase in the tuition and fees for the certificate program to \$17,500.00 per student effective January 1, 2006 and \$19,500.00 per student effective January 1, 2007; however the report did not include the amount that CCC would pay the FPS, therefore a ratification of payments made to FPS is requested for \$14,606 per student in the certificate program with a total amount of \$1,866,316 from January 1, 2006 through December 31, 2006; and

that the City Colleges of Chicago ("CCC") desires to continue their relationship with the French Pastry School to provide certificate and continuing education programs in the baking and pastry arts (collectively referred to herein as "programs"); and

that the internationally renowned French Pastry School ("FPS") has operated a baking and pastry arts training program with CCC and desires to continue its affiliation with CCC to design, provide, market and administer the programs: and

that FPS has developed a twenty four week curriculum for the certificate program that will be offered a minimum of two and a maximum of four times per year. Tuition and fees will be \$19,500.00 per student of which CCC pays FPS \$16,606.00 per student for instructional cost and which will be renegotiated on a yearly basis; and

that FPS has developed continuing education courses that will be offered in addition to the certificate program; Tuition and fees per student will be based on the current market price of which CCC pays FPS 74% per student for instructional cost and which will be renegotiated on a yearly basis; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced program agreement between French Pastry School and the City Colleges of Chicago and since this project involves the continuation of an existing relationship between the aforementioned, it is recommended that a waiver from compliance with the Board approved Participation Plan be granted.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees authorize the Chairman to negotiate and execute a ten year agreement with the FPS to provide classes leading to a certificate in Pastry Arts and continuing education classes in the baking and pastry arts beginning January 1, 2007 to December 31, 2017 and ratify payments made to the French Pastry School in the amount of \$1,866,316 beginning January 1, 2006 through December 31, 2006.
