REPORTS

that in Board Report #27348 dated 05-04-06, the Board authorized the architectural/engineering services of Bauer Latoza Studio, Chicago, IL, to assist in designing and developing architectural drawings to be used with bidding documents for the exterior terrace renovation of the Parrot Cage Restaurant at the South Shore Cultural Center located at 7059 S South Shore Drive, Chicago, Illinois, owned and operated by the Chicago Park District (CPD) in the amount of \$25,000; and

that it is necessary to acquire this firm's services to assist in designing and developing additional architectural drawings to be used with bidding documents for the wall surface improvement, and kitchen shelving project. Said project include adding a durable, cleanable wall surface to areas within the Washburne Culinary Institute site at the South Shore Cultural Center; and

that Bauer Latoza Studio has proposed a total fee of \$25,295.00 which does not include anticipated reimbursable expenses estimated to be \$3,705.00 which totals \$29,000.00 bringing the total project cost to \$64,277.00; and

that the initial award to Bauer Latoza Studio [Board Report #27348 dated 05-04-06] was made on the basis of a publicly advertised solicitation of qualifications, and staff in the Office of Facilities Planning is satisfied with the work of the firm, and the current proposal is considered reasonable and acceptable; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced Parrot Cage Restaurant renovation project and since Bauer Latoza Studio is pre-qualified and certified as a WBE, therefore, they are in compliance with the Board approved Participation Plan.

RECOMMENDS

that the Board of Trustees authorize the Chairman to amend the original agreement with Bauer Latoza Studio to provide the additional architectural services as described above in an amount not to exceed \$29,000.00 beginning Jan 4, 2007 through June 4, 2007 bringing the total project cost to \$64,277.00.
