**NEW PROPOSALS OR GRANTS**

**Illinois Sustainable Energy Education Consortium (PD# 080801)**

Wright College has received a subaward of \$80,000 from an award to Kankakee Community College (\$490,000) from the Illinois Department of Commerce and Economic Opportunity. The project calls for a statewide consortium of community college sustainable energy education centers. The project also involves Heartland College and Lewis and Clark College. The performance period for this project is from July 1 2008 through June 30, 2009.

**Health Occupations Careers: Nursing Programs (PD# 080803)**

Kennedy-King College has submitted a proposal to the US Department of Education for a project to strengthen training in health occupation careers in the areas of nursing for those individuals who are considered to have disadvantaged backgrounds and are categorized as "needy". The proposals requests \$1,118,141 for the performance period from October 1, 2008 through October 30, 2010.

**Community Services Agreement (PD# 080804)**

Harold Washington College has received an award from the Illinois Department of Human Services of \$547,189 to support the Developmental Disabilities Programs. The performance period for this project is from July 1, 2008 to June 30, 2009.

**Illinois Support, Training & Employment Program (ISTEP) (PD# 080805)**

Olive Harvey College has received an award of \$58,190 from the Illinois Department of Labor for a project that will assist participating displaced homemakers in achieving economic self-sufficiency through education, training and employment. The project will provide advising, training, career assessment, life skills and job related workshops and referrals to a variety of

organizations and agencies. The performance period for this project is from July 1, 2008 through June 30, 2009.

**Grow Your Own Teachers (PD# 080806)**

Northeastern Illinois University has been funded by the Illinois State Board of Education for a project to help communities train and retain teachers for local schools. The grant includes a subcontract for Daley College, of \$20,185, to pay for office supplies, travel and college advisors. The performance period for this project is from September 1, 2007 through August 31, 2008.

**Bank Teller Training and Placement Services (PD# 080807)**

The District Office has submitted a request for \$10,000 to the Citibank Foundation to use to help provide recruitment, assessment, customized training and placement services to prospective bank tellers. The performance period for this project is from September 1, 2008 through August 31, 2009

**Real Men Choose Nursing: Strategies for Recruitment and Retention of Males in the Nursing Profession (PD# 080809)**

Olive Harvey College has submitted a request for \$1,500 to the FY'09 New Look Project to help recruit and retain males in the nursing profession. The New Look Project is housed at Illinois State University. The performance period for this project is from September 1, 2008 through August 31, 2009.

**TCF Scholarships for Youth Worker Program (PD# 080802)**

Harold Washington College has received a donation of \$20,000 from TCF Bank to be used for 10 scholarships of \$2,000 each beginning in the Fall, 2008 semester for the Harold Washington College Youth Worker Program.
