NEW PROPOSALS OR GRANTS

Grow Your Own Teachers (PD# 080701)

The Organization of the NorthEast (ONE) has been awarded a grant from the Illinois State Board of Education which includes a sub-award to Truman College for \$25,095. Truman's project will provide course work and support services in the Rogers Park, Edgewater and Uptown areas. The performance period for the project is from May 31, 2007 through August 31, 2008.

NIGMS Internship Project (PD# 080702)

Truman College has received an award of \$15,000 from the American Psychological Association to provide summer internships to Truman students who participate in CALF/CSS programs (Center for Achievement in the Life Sciences / Center for Science Success). The performance period for this program is from June 1, 2008 through September 30, 2008.

Illinois Support, Training & Employment Program (ISTEP) (PD# 080703)

Malcolm X College has received an award of \$58,190 from the Illinois Department of Labor for a project that will assist participating displaced homemakers in achieving economic self-sufficiency through education, training and employment. The project will provide advising, training, career assessment, life skills and job related workshops and referrals to a variety of organizations and agencies. The performance period for this project is from July 1, 2008 through June 30, 2009.

Susan Harwood Training Grant Program (PD# 080704)

Truman College has submitted a proposal to the US Department of Labor's Occupational Safety and Health Administration (OSHA) for \$232,405 for a project which will provide bilingual forklift safety training to Spanish and Polish speakers and develop and deploy a "train the trainer" program in forklift safety. The performance period for this project is from October 1,

2008 through September 30, 2009.

Community College Caregiver Training Inititiative (PD# 080705)

Malcolm X College has submitted a proposal for \$24,520 to the American Association of Community Colleges for a project which will implement a certificate-granting curriculum for Home Caregivier. The project will provide a four-week training program to 50 persons during the performance period, from October 1, 2008 through September 30, 2009.

Cooperative Work Study (PD# 080706)

Harold Washington College has received funding of \$31,438 from the Illinois Board of Higher Education to support cooperative work study programs by paying a portion of the salaries that students earn while in their internship positions in business and industry. The performance period for this project is from June 3, 2008 until June 30, 2009.

Cooperative Work Study (PD# 080708)

Kennedy-King College has received funding from the Illinois Board of Higher Education for \$14,763400, to support cooperative work study programs by paying a portion of the salaries that students earn while in their internship positions in business and industry. The performance period for this project is from June 3, 2008 until June 30, 2009

Strengthening Undergraduate Research Mentoring (PD# 080709)

Wright College has submitted a proposal for \$15,000 to the American Association of Community Colleges for a project that would strengthen faculty undergraduate research in environmental biology by providing mentoring support. The performance period for this project is from July 1, 2008 through June 30, 2010.

Technology Empowering Women (PD# 080710)

Daley College has submitted a proposal to the U.S. Department of Justice for \$421,150.00 to assist female ex-offenders with employment by providing training activities in technology related areas. The performance period for this project is from November 1, 2008 through December 31, 2009.

Renewable Energy Education Credit Course Development for Community College Curricula (PD# 080711)

Wright College has submitted a proposal to the National Science Foundation for \$150,000 to be used to develop new curricula in the area of renewable energy studies. The performance period for this project is from January 15, 2009 through January 14, 2011.

Biotechnology Program and Research: The Road to Career Development in Two Year Colleges (PD# 080712)

Harold Washington College has submitted a proposal to the National Science Foundation for \$149,954 for a project which will develop a career pathway program in biotechnology. The performance period for this project if from January 1, 2009 through December 31, 2010.

2009 Community Development Block Grant (PD# 080713)

Kennedy-King College has submitted a proposal to the Mayor's Office of Workforce Development (MOWD) for \$30,555 for a project which will provide training opportunities for students to gain professional and technical skills necessary for successful employment and continued education in the automotive industry. The performance period for this project is from August 1, 2009 through May 1, 2010.

Sencer NOAA Mini Proposal (PD# 080714)

Truman College has submitted a proposal for \$24,000 to the National Center for Science and Civic Engagement for a project to increase environmental literacy for general science and k-12 preservice teachers by including civic and Great Lakes content in Biology courses and through partnerships with National Oceanic and Atmospheric Administration (NOAA) entities. The performance period for this project is from September 1, 2008 through August 31, 2011.
