Committee Chair, Rev. Tyson, III called the Board Committee meeting on Academic Affairs to order at 10:30 a.m. Vice Chancellor, Angela Henderson presented the following report for Academic Affairs:

1. Vice President, Cecile Regner presented a report on Daley College Manufacturing Renaissance goals: Renew Industry Partnerships, Enhance Curriculum, Upgrade Equipment, Recruit Quality Instructors & Staff, Renovate Lab and Classrooms, Design 12 month Project Plan, Deliver state-of-the-art Metal Working Program
2. Dr. Jana Fleming, Executive Director Child Development Studies, presented an update on the Child Development program. This is the first time a Child Development budget has been brought to the Board (\$457,050.10). Staffing changes have taken place; all new positions were created. Some staff was rehired in addition to some outside hiring. Education requirements were raised for several positions to maintain compliance. Dr. Fleming is working with Human Resource, Finance and a Union Representative. Another update will be forthcoming after the Fall Semester.
