that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

NEW PROPOSALS OR GRANTS (Total Value \$3,395,448)

Pritzker EQUIP Proposal (PD# 090801)

The District Office is applying for an EQUIP grant from the Pritzker Early Childhood Foundation and Prince Charitable Trusts collaborative for an early childhood education project. The request for \$7,000 to serve predominantly low income children in Chicago focusing on the need to improve the mental health consulting services delivered at Malcolm X and Truman Colleges child development lab centers. The performance period for the project is from Sept. 1, 2009 through Aug. 31, 2010.

David and Jean Stremmel Fund (PD# 090802)

The Chicago Community Foundation has made a grant of \$1,000 to WYCC-TV20, from the David and Jean Stremmel Fund of the Foundation. The grant is to be utilized to support the Charlie Rose Show and the award has no specific time limitations for expenditure.

Teacher Quality Enhancement Grant Partnership (PD# 090803)

Daley College has received a subaward from Illinois State University to pay for the tuition costs for an ACT Preparation course for 30 students @ \$189.00. The award of \$5,670 will be available during the period ending September 30, 2009. However, payment is for the course which is scheduled to end on August 6, 2009.

Green A+ Computer Recycling and Refurbishing (PD# 090804)

Daley College has submitted a proposal for \$375,000 to the Cook County Board to provide training in computer recycling and entry-level information technology skills including A+ certification. The performance period for this project is from September 1, 2009 through April 30, 2011.

WIA - Training Pathways to Better Jobs (PD# 090805)

Truman College has partnered with the Jane Addams Resource Corporation to submit a proposal for \$155,636 to the Chicago Department of Community Development for a project that will provide job training for adults in applied office technology for both health care and information technology. The performance period for this project is from July 1, 2009 through June 30, 2020

Pathways to Success Bridge Program (PD# 090806)

Wright College has submitted a proposal for \$300,000 to the Chicago Department of Community Development for a project that will train low-income adults with essential skills to enter and advance in the fields of manufacturing and health care. This project is a partnership with the Erie Neighborhood House. The performance period for this project is from July 1, 2009 through June 30, 2010.

Empowering Community College Students to Become Scientists (PD# 090808)

Wright College has received a grant of \$2,000 from the Delta Kappa Gamma Educational Foundation to support a research mentoring program for biology students. The funds will pay for research supplies during the 2009-2010 academic year.

Heating and Cooling Technical Engineering Green Energy Program (PD# 090809)

Kennedy-King College has submitted a proposal for \$2,340,665 to the Partnership for New Communities to offer training in heating, ventilation and air conditioning/refrigeration careers for Chicago Housing Authority residents and/or relocates. The performance period for this project is from September, 2009 through August, 2010.

Child Development Program Resource Project (PD# 090810)

Kennedy-King College has submitted a proposal for \$104,877 to the Learn and Serve America Higher Education Federal Program. The project would provide student administered community service and service learning programs through bi-weekly forums, best practices workshops, community health fairs and a directory resource guide. The performance period for this project is from August, 2009 through May, 2012.

Chicago Partnership for Research and Training on Health Disparities (PD# 090811)

Kennedy-King College is a partner in a University of Chicago project which supports activities to increase research addressing health disparities

and to significantly expand and enhance a pipeline training program. The grant of \$1,000,000 to the University of Chicago will provide a sub-award to Kennedy-King College of \$103,600 during the two year period which begins on September 1, 2009.

AMENDMENTS

Exemplary Research Career Opportunity Intervention for Community Colleges (PD# 090702)

Kennedy-King College has agreed to be a partner in an innovative research proposal, submitted by the University of Michigan (rather than the University of Maryland, Baltimore County, as previously reported) to the National Institutes of Health, for a project that will design and explore the effectiveness of an intervention to increase the number of underrepresented minority students who enter graduate studies for careers as research scientists. The two year project requests a total of \$999,329 and will subcontract with Kennedy-King College during the period from January 1, 2010 through December 31, 2011.

DONATIONS OR GIFTS (Total Value \$500,000)

Workforce Investment Partnerships (PD# 090807)

The City of Chicago, Department of Community Development, has agreed to provide full time Workforce Investment Act case managers at Olive-Harvey, Kennedy-King, Malcolm X, Truman and Wright Colleges and a half-time case manager at Harold Washington College. The case managers will report to the Career Deans (or other appropriate administrators) and salaries and benefits of the case managers, provided by the Department of Community Development, are estimated at \$500,000. The performance period for the initial provision of case managers is from August 15, 2009 through June 30, 2010.

THE CHANCELLOR

RECOMMENDS that the Board of Trustees approve acceptance of any gifts, grants or other funding which may be forthcoming from these proposals and authorize the Chancellor, the Vice Chancellor for Academic Affairs, or the District

Director for Grants and Contracts to serve as *authorized representative* or *official representative* of the District in the submission of proposals for funding and to execute all documents for the acceptance of this funding or these gifts and the operation of the funded projects; said acceptance to be subject to the terms and conditions set forth by the grantor, including specified subcontracts and purchases, and said funds not to be expended by the Board for any other purposes.
