that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

NEW PROPOSALS (Total Amount Proposed \$1,844,407)

Urban Community College Transfer Consortium PD# 091203)

Olive-Harvey College is a partner with the University of Michigan, the University of Illinois at Chicago and Wayne County Community College in Detroit, in a proposal to the National Institutes of Health for a project that will provide interventions to improve pipelines for mathematics centered careers. The proposal requests \$1,451,159 for a four year project that includes a subcontract for Olive-Harvey College of \$160,073. The performance period for this project is from July 1, 2010 to June 30, 2014.

Community Renewable Energy Program (PD#091206)

Wright College has submitted a request for \$72,000 to the Illinois Department of Commerce and Economic Opportunity for a project that would build a teaching/demonstration wind turbine on campus. The project would involve site assessment, local permitting, procurement, administration, engineering, installation and operation of the turbine. The performance period for this project is from January 1, 2010 to September 15, 2010.

DHS Scientific Leadership Bridge Awards for Minority Serving Institutions (PD# 091207)

Wright College has submitted a request for \$69,182 to the US Department of Human Services for a grant which will provide tuition and support for 20 student participants to encourage them to participate in scientific leadership activities and continue to work towards careers in environmental science. The performance period for this project is from September 20, 2010 through September 2, 2013.

Orbifolds: Geometry, Topology and Category Theory (PD# 091208)

Wright College has submitted a proposal for \$119,450 to the National Science Foundation to support a research investigation into an area of algebraic topology which could result in new applications in several fields. The performance period for this project is from April 1, 2010 through March 30, 2013.

Bridge to Science Careers (PD# 091209)

Kennedy-King College has submitted a proposal for \$1,423,702 to the National Science Foundation for a project that would support student participation in programs that prepare students for careers in science and mathematics. The performance period for this project is from January 1, 2010 through December 31, 2014.

NEW AWARDS (Total Amount Awarded \$49,108)

Grow Your Own Consortium (PD# 091205)

Malcolm X College has received a subaward of \$49,108 from Illinois State University for a project that will encourage and support students to become candidates for elementary school teaching positions. The project pays for tutors, textbooks and tuition. The performance period for this project is from July 1, 2009 through June 30, 2010.

CONTINUING AWARDS (Total Value \$1,439,363)

Gear Up Alliance (PD# 091201)

Northeastern Illinois University has awarded a subcontract of \$40,000 to Truman College for year five of a six year award from the US Department of Education to work with the Chicago Public Schools to improve student achievement. The performance period for this award is from September 1, 2009 to August 31, 2010.

Head Start / Child Care Collaboration (PD# 091202)

City Colleges of Chicago has completed an application to be submitted to the Chicago Children and Youth Services Department (CYS) for continued funding of the Head Start Program for children of low income parents at the Kennedy-King, Malcolm X, Olive-Harvey, Daley and Truman Child Development Centers. The District is applying for 228 Head Start Collaboration and Child Care slots, which would provide funding in the amount of \$930,356. The performance period for the grant is from December 1, 2009 to November 30, 2010.

Head Start Support Services (PD# 091204)

Harold Washington College has received notice from the Chicago Department of Family and Support Services for the refunding of the Support Services agreement in the amount of \$469,007. This contract is to provide training and educational services to Head Start employees for the CDA credential and/or Associate in Applied Science degrees in Child Development or Social Services. The performance period for this contract is from December 1, 2009 to November 30, 2010.

that the Board of Trustees approve acceptance of any gifts, grants or other funding which may be forthcoming from these proposals and authorize the Chancellor, the Vice Chancellor for Academic Affairs, or the District Director for Grants and Contracts to serve as *authorized representative* or *official representative* of the District in the submission of proposals for funding and to execute all documents for the acceptance of this funding or these gifts and the operation of the funded projects; said acceptance to be subject to the terms and conditions set forth by the grantor, including specified subcontracts and purchases, and said funds not to be expended by the Board for any other purposes.
