REPORTS that there is a need to demolish the retired Kennedy King College Campus which has been out of service for two years and whose restoration is cost prohibitive; and

pursuant to RFQ #NU0818 adopted by Board Report #29438, Teng and Associates was hired in May of 2009 to survey the property and design a technical specification for public bid to abate all hazardous waste; demolish the physical structures; remediate all contaminated soil; and restore the site as a green space; and

that the recommended demolition contractor will provide CCC with a full range of demolition construction and related management services including, but not limited to, securing and insuring the site; managing the abatement of hazardous waste and demolition activities; remediating contaminated soil; implementing the site design plan; and complying with all City, State and Federal regulations; and

that on October 6, 2009 a Request For Sealed Bids #DT0916 was publicly advertised by CCC and posted on CCC's website. On October 27, 2009 eight (8) bids were received for the Abatement and Demolition contract awards. Brandenburg Industrial Service Company was selected as the lowest responsive and responsible contractor; and
