**REPORTS**

that there is a need to purchase health supplies for various Allied Health programs on an as needed basis throughout the District; and

that the Districts Office of Business and Procurement Services has determined that it is more feasible and cost effective to utilize the following State of Illinois Central Management Services (CMS) contracted vendors: Austin Medical Equipment-Westchester, IL; Kentron Health Care, Inc.-Springfield, TN; McKesson Medical –Surgical MN-Golden Valley, MN; Medline Industries Inc.-Vernon Hills, IL; Moore Medical U C-Farmington, CT; Professional Medical Inc.-New Lenox, IL; Progressive Industries, Inc.-Chicago, IL; Supreme Medical Fulfillment-Mobile, AL; and

that these vendors were selected on a competitive basis through advertised Bid Specification #223631 and authorized by Contract No.'s 4015605, 4015606, 4015607, 4015608, 4015609, 4015610, 4015611, 4015612 dated April 1, 2009 through March 31, 2010; and

that Procurement Services staff is requesting approval to utilize services from the various State of Illinois CMS Hospital Supply vendors District-Wide on an as needed basis from July 14, 2009 through March 31, 2010, in a total amount not to exceed \$100,000; and

that contracts for goods and services procured from another governmental agency are exempt from the District's competitive bidding requirements; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced proposal to purchase hospital supplies from the various vendors and, utilizing the listing from the State of Illinois Office of Central Management Services, which reflects certified MBE and WBE firms in compliance with the goals per bid specifications, is therefore in compliance with the Board Approved Participation Plan.

that the Board of Trustees approve the issuance of purchase orders to Austin Medical Equipment-Westchester, IL; Kentron Health Care, Inc.-Springfield, TN; McKesson Medical –Surgical MN-Golden Valley, MN; Medline Industries Inc.-Vernon Hills, IL; Moore Medical U C-Farmington, CT; Professional Medical Inc.-New Lenox, IL; Progressive Industries, Inc.-Chicago, IL and Supreme Medical Fulfillment-Mobile, AL in a combined amount not to exceed \$100,000 for staff to purchase Hospital Supplies District-Wide from July 14, 2009 through March 31, 2010.
