THE CHANCELLOR

REPORTS

that in Board Report #27401 dated June 8, 2006 the Board authorized the Chairman to enter into an agreement to provide educational books, periodicals and other instructional materials with Baker & Taylor the primary firm for \$585,000, an agreement with Steck-Vaughn a preferred vendor for \$300,000, an agreement with Cengage Learning (formerly -Thomson/Gale; Gale Group Inc.), a preferred vendor for \$435,000 and an agreement with H.W. Wilson a preferred vendor for \$90,000, for a three year period beginning June 30, 2006 through June 29, 2009 with an option to extend for an additional two (2) year period, in accordance with RFP# IW0602 dated January 1, 2006; and

that there is a need to continue the purchasing of periodicals, books, reference books and instructional materials for the libraries and for students in various programs at all colleges district wide; and

that the staff recommends that the Board exercise the option to extend the agreement with Baker & Taylor in the amount of \$390,000, Steck-Vaughn in the amount of \$200,000, Cengage Learning (formerly -Thomson/Gale; Gale Group Inc.) in the amount of \$290,000 and H.W. Wilson in the amount of \$60,000 for an additional two (2) year period from June 14, 2009 to June 13, 2011 under the same terms and conditions; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced option to extend and the above referenced vendors remain in compliance with the Board Approved Participation plan.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees authorizes the Chairman to extend the existing agreements in accordance with RFP # IW0602 dated January 1, 2006 with the vendors listed as follows: \$390,000 for Baker & Taylor, \$200,000 for Steck-Vaughn, \$290,000 for Cengage Learning (formerly -Thomson/Gale;Gale Group Inc.), and \$60,000 for H.W. Wilson for the purchase of periodicals, books, reference books and instructional materials for libraries and for students in various programs at all colleges district wide beginning June 14, 2009 through June 13, 2011.
