THE CHANCELLOR

REPORTS

that there is a need to provide integrated pest management services for all City Colleges of Chicago facilities; and

that staff has determined that it is more feasible and cost effective to utilize CPS contracted vendors approved through their advertised Bid Solicitation # 06-250000, dated April 10, 2006; approved under CPS Board Report # 07-0124-PR6 dated January 24, 2007 for pest management services on an as needed basis; and

that in Board Report No. 28335 adopted October 3, 2007, the Board authorized the issuance of purchase orders on an as needed basis to Alpha Omega Pest Control Corp., Concern Pest Control, Smithereen Exterminating Co., Anderson Pest Control, Orkin Pest Control and Quality & Excellence Pest Control Inc., to provide integrated pest management services District Wide, utilizing the CPS contract through February 28, 2009, including any approved CPS extension period, and in Board Report No. 29154 adopted December 2, 2008 to issue purchase orders on an as needed basis for a total amount not to exceed \$50, 000 to the approved pest control companies listed above for pest control services through February 28, 2009 including any approved CPS extension period; and

that staff is requesting approval to utilize pest management services on an as needed basis through the following vendors currently under contracts with CPS for Board Report # 07-0124-PR6 through February 28, 2009, with options to renew for a (1) one additional (1) one year period: Alpha Omega Pest Control Corp. Chicago, IL., Concern Pest Control Chicago, IL., Smithereen Exterminating Co. Niles, IL., Anderson Pest Control, Elmhurst, IL., Orkin Pest Control, Chicago, IL., Quality & Excellence Pest Control Inc., Calumet City, IL.,; and

that CPS extended the agreement for integrated pest management services for a term commencing March 1, 2009 and ending February 28, 2010; and

that contracts for goods and services procured from another governmental agency are exempt from the District's competitive bidding requirements; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced intergovernmental pest management services agreement utilizing the CPS Board Report #07-0124-PR6, as part of the authorized joint purchasing agreement with the City of Chicago, the firms utilize participation from certified M/WBE vendors in compliance with the goals, and is therefore deemed to be in compliance with the Board Approved Participation Plan.

RECOMMENDS

that the Board of Trustees approves the issuance of purchase orders in the amount of \$50,000 on an as-needed-basis to the approved pest management services companies listed above through the end of the current CPS contract ending February 28, 2010.
