¹ The original Training Agreement was between Vienna Beef and Wright College and had a term date of 07/1/08 to 6/30/09 at a cost of \$69,573.00. Because the cumulative dollar amount for this vendor exceeded \$10,000, board approval was required and granted on 10/2/08. The Amendment extends the date of the original agreement. The new term date is 7/1/08 to 6/30/10. In addition, the training program will now be administered by the Harold Washington College's Workforce Institute.

² The original Short Term Facilities Use Agreement was approved by the Board on April 2, 2009. In the interim, the vendor submitted the Rider and is requesting that we execute it and make it a part of the Short Tem Facilities Use Agreement. The date remains unchanged. There is not cost involved.
