THE CHANCELLOR

REPORTS

that in Board Report # 27032, dated November 3, 2005, the Board of Trustees approved an agreement with the Oracle Corporation in the amount of \$2,750,000.00 for the period November 7, 2005 through November 6, 2007 for professional services relating to the PeopleSoft applications and Oracle's fusion technology; and

that in Board Report # 28374, dated November 2007, the Board of Trustees approved an amendment of the agreement with the Oracle Corporation amending the term of the agreement until June 30, 2009; and

that OIT has forecasted that a balance of \$1,499,921.00 will be available on June 30, 2009 from the original authorization of \$2,750,000.00; and

that during FY2010, it is necessary to continue to use professional services from the Oracle Corporation on an as needed basis to provide consultants knowledgeable in the following areas:

- Provide assessments of the features and functionality of the PeopleSoft applications;
- Perform PeopleSoft application and Oracle database tuning;
- Provide guidance on the features of the Oracle applications functionality;
- Provide guidance in the development and use of middleware software;
- Assist in creating a strategy to upgrade Oracle PeopleSoft Tool versions (8.4.x);
- Provide technical and functional reviews when required; and

that OIT recommends that to continue the professional service agreement with the Oracle Corporation for the period of July 1, 2009 through June 30, 2010 at a cost not exceed \$1,499,921.00 which includes expenses; and

that this professional service agreement is exempt from the District's competitive bidding requirements; and

that the Office of Contract Compliance has reviewed the above referenced software maintenance and training services agreements and, as this is an extension in time to the original agreement with no increase in cost, is recommending the waiver of compliance with the Board approved Participation Plan be continued as previously approved.

THE CHANCELLOR

RECOMMENDS that the Board of Trustees approves an agreement with the Oracle Corporation for the period of July 1, 2009 through June 30, 2010 for professional services relating to the PeopleSoft applications and Oracle's database and fusion technology at a total amount not to exceed \$1,499,921.00 including expenses and authorizes the Chairman of the Board to execute any documents pertaining to these professional services.
