that specifications were prepared by District Procurement staff, publicly advertised and twelve (12) vendors were notified; a pre-bid conference was held on March 20, 2009, and two (2) bids were submitted from Laerdal Medical Corporation and Medical Education Technologies, Inc. (METI) and two (2) no-bids from Medical Device Depot, Inc. and Bound Tree Medical. The following bids were received:

that staff has determined that it is in the best interest to award the nursing simulation equipment based on the overall total lump sum bid; and

that staff recommends the supply, delivery and installation of the nursing simulation equipment and related services from Laerdal Medical Corporation for Daley College and Kennedy-King College; and

that the Office of M/WBE Contract Compliance has reviewed the above submittal and, Laerdal a manufacturer of medical equipment that provides training and service for all of its equipment and is requesting a waiver for subcontracting to certified M/WBE firms and seeking consideration of the participation of factory trained minorities and women trainers and technicians, is recommending approval of the request for waiver for compliance with the Board Approved Participation plan.
