that there is a need to purchase an automotive training system for the Automotive Technology Program of Truman College to allow the students to study and troubleshoot twelve separate electrical/electronic systems simultaneously; and

that specifications were prepared by District staff, publicly advertised, and eleven (11) vendors were notified; a pre-bid conference was held on March 3, 2009, and the following two (2) firms submitted bids as listed below:
