that there is a continuing need for the colleges to rent 15-passenger seat vans throughout the year for various programs, sports teams, events and student events; and

that specifications were prepared by District Procurement staff, publicly advertised on August 27, 2009 and emailed to thirty-six (36) prospective firms. A pre-bid conference was held on September 8, 2009 and the following three bids were received: Enterprise Leasing Company of Chicago-Bridgeview, IL, Allard Rental Corporation-Highland, IN and Paragon Auto Leasing Co.-Chicago, IL:

that the Office of M/WBE Contract Compliance has reviewed the above submittal and, Enterprise Leasing Company of Chicago utilizing Illinois Truck Center, a certified WBE and Ujamaa Construction a certified MBE and is in compliance with Board Approved Participation plan.

RECOMMENDS

that the Board of Trustees authorizes the Chairman to enter into an agreement with Enterprise Leasing Company of Chicago-Bridgeview, IL for the rental of 15-passenger seat vans based on the daily rate of \$99.00 per van and weekend (Friday after 3:00 p.m. and return Monday before 10:00 a.m.) rate of \$249.97 per van and authorization of mandatory insurance coverage per van rental as listed above for a three (3) year period from December 1, 2009 – December 31, 2012 in an annual amount not to exceed \$100,000.000 with an option to extend for an additional two (2) year period, in accordance with Sealed Bid #MWJ0910 dated August 27, 2009.
