that in Board Report 28754, dated June 5, 2008, for a three year period from July 1, 2008 through June 30, 2011 at an annual cost of \$51,931.00, the Board approved a support agreement with Compuware Corporation relating to their Test Partner, QA Center Performance Edition, QA Center Enterprise Edition II and Client Vantage, Server Vantage & Vantage Analyzer software products; and

that OIT uses the various software products to monitor system connectivity and conduct performance testing activities such as load testing, performance tuning, application diagnostics and capacity planning of the PeopleSoft Student Administration, Financial and Human Resources systems; and

that on June 1, 2009, Micro Focus Inc. acquired the licensing and ownerships rights for Test Partner, QACenter Performance Edition, and QA Center Enterprise Edition II software products from Compuware; and

that OIT has received a revised support agreement from Compuware and a new support agreement from MicroFocus Inc. for the period of July 1, 2009 through June 30, 2011 as listed below:

Compuware - Client Vantage, Server Vantage &

Vantage Analyzer products \$28,708.00 annual

Micro Focus - Test Partner, QA Center \$22,323.00 annual

Performance Edition and QA Center Enterprise Edition II products

Total \$51,031.00 annual; and

that the combined costs are less then the original annual cost of \$51,931.00 approved

that the Office of M/WBE Contract Compliance has reviewed the above referenced agreement and, there are no certified M/WBE vendors to supply and support the product currently used by OIT in its applications, is recommending a waiver of compliance with the Board Approved Participation plan.

**RECOMMENDS** that the Board of Trustees approves the amendment to the agreement with Compuware Corporation for software maintenance support for a period of two years from July 1, 2009 to June 30, 2011 at an annual cost not to exceed \$28,708.00 and authorizes the Chairman to enter into an agreement with Micro Focus Inc. for software

> maintenance support for a period of two years from July 1, 2009 to June 30, 2011 at an annual cost not to exceed of \$22,323.00.
