### **NEW PROPOSALS OR GRANTS (Total Value \$ 4,072,282)**

# <u>Dropout Retrieval: Empowerment for Academic Matriculation at Truman College (PD# 090901)</u>

The District Office anticipates receiving notification of refunding by the Youth Connection Charter School (with funds flowing through the Chicago Public Schools) for a program to provide academic programs and services for retrieved high school dropouts in the CCC middle colleges. Anticipated funding for the Middle College Program at Truman College is \$935,505. The performance period for this project is from July 1, 2009 through June 30, 2010.

### **Dropout Retrieval Supplemental for Truman (PD# 090902)**

Additional funding \$72,765 will be provided by the Illinois State Board of Education under *Supplemental General State Aid* (SGSA) and by the U.S. Department of Education using Chapter I funding. The performance period for this project is from July 1, 2009 through June 30, 2010.

# <u>Dropout Retrieval: Empowerment for Academic Matriculation at</u> Olive Harvey College (PD# 090903)

The District Office anticipates receiving notification of refunding by the Youth Connection Charter School (with funds flowing through the Chicago Public Schools) for a program to provide academic programs and services for retrieved high school dropouts in the CCC middle colleges. Anticipated funding for the Middle College Program at Olive Harvey College is \$1,178,244. The performance period for this project is from July 1, 2009 through June 30, 2010.

### **Dropout Retrieval Supplemental for Olive Harvey (PD# 090904)**

Additional funding \$78,200 will be provided by the Illinois State Board of Education under *Supplemental General State Aid* (SGSA) and by the U.S. Department of Education using Chapter I funding. The performance period for this project is from July 1, 2009 through June 30, 2010.

# <u>Developing Career Pathways: Targeting Developmental Education</u> <u>Students and Transitioning Them into Productive Careers (PD# 090905)</u>

Harold Washington College received notice of funding for it's Title III proposal from the US Department of Education. The total award for five years is \$1,416,608. The grant will support efforts to target those students who do not pass our Reading, Writing, and Math placement tests and are, therefore, placed in developmental courses. The project will work intrusively with these students to get them into career programs and jobs. The performance period for the first year of funding is from October 1, 2009 through September 30, 2010.

### Women in Nanotechnology (PD# 090906)

Truman College has received an award of \$5,000 from the US Department of Labor's Women's Bureau to raise awareness of nanotechnology careers for at least 10 women who are community college students. The project includes field trips, scholarships, e-mentoring and an opportunity to compete for \$500 scholarships. The performance period for this project is from August 3, 2009 through July 31, 2010.

### Recovery Act: Solar Market Transformation (PD# 090908)

Wright College has submitted a proposal to the US Department of Energy - Golden Field Office for a project to develop a curriculum and provide accredited and certificated training in solar energy (selling, designing, engineering, installing, commissioning, repairing and code enforcement). The proposal requests \$297,960 for the period from10/01/2009 through 9/30/2011.

## Reflective Learning in Action (PD# 090907)

The District Office has received an award of \$23,200 to fund a project which will enhance the relationship between teachers and student teachers in the child development laboratory centers and the child development departments of the City Colleges of Chicago. The project will fund monthly meetings, team building exercises and professional presentations. The performance period for this project is from February 1, 2009 through June 1, 2010.

# Re-Engineering Translation Research at the University of Chicago with Kennedy-King College (PD# 090909)

The University of Chicago has received funding from the Department of Health and Human Services for a project which has a subaward of \$64,800 for Kennedy-King College. Kennedy-King students and faculty members will participate in three interdisciplinary projects aimed at eliminating health disparities among underserved populations: HPV molecular analysis, racial identity and cancer disparities and disparities in smoking cessation and nicotine metabolism. The performance period for the project is from September 30, 2009 through September 29, 2011.

# Exploring New Models for Authentic Undergraduate Research with Two-Year College Students (PD# 060616 - YR4)

Harold Washington College has received notification from the National Science Foundation of funding of the fourth year of this project, for \$500,000, to support the collaborative effort which links ten 2-year colleges with research institutions in the Chicago area to support productive research experiences for students. The total cumulative award is now \$2,200,000 and the new expiration date is September 30, 2010.

# <u>Truants' Alternative and Optional Education Program</u> (TAOEP) (PD# 090613)

The District Office has received funding of \$ 1,930,716 for a continuation project from the Illinois State Board of Education. This program is a unique partnership between public, private and community-based organizations designed to provide alternative educational programs and services to reclaimed youth, 16-21 years old, who have dropped out of high school. The Truman Middle College and the Olive Harvey Middle College will receive funding from this award. The performance period for this project is from July 1, 2009 to June 30, 2010. From the grant funds, the following diploma programs and GED programs will utilize subcontracts from the City Colleges of Chicago:

The District Office has received an initial (50%) award from the Illinois Department of Human Services of \$241,721 to fund the supported employment (\$131,731) and the Vocational Development (\$ 109,990) Programs at Harold Washington College. The performance period for this project is from July 1, 2009 to December 31, 2009.
