REPORTS

that in Board Report #28432 adopted on December 6, 2007, Board Report #27841 adopted on February 8, 2007, Board Report # 26477 adopted December 2, 2004 and Board Report# 27174 dated February 9, 2006 approval was given to purchase and upgrade AutoCAD software from Imaginit Technologies for the credit and continuing education computer aided design training programs at various Colleges; as well as extend software license agreements that have expired at the Colleges; and

that to maintain the training programs and to prevent disruption of services, it is requested that CCC renew the license agreement with Imaginit Technologies for a one year period beginning December 31, 2008 through December 30, 2009; and

that currently, Truman College, Daley College, Harold Washington College and Wright College have educational licenses, while Administrative Services has two (2) commercial, non educational licenses; and

that Imaginit Technologies software license renewal fees are listed as follows for these campuses:

that approval is requested to ratify the contract beginning dates to avoid any disruption in service; and

that this is a sole source procurement for AutoCAD training programs and license renewal fees and is therefore exempt from the District's competitive bidding requirements; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced software license renewal with Imaginit Technologies and since there are no certified MBE or WBE subcontracting opportunities, a continuation of the approved waiver from compliance with the Board approved Participation Plan is recommended.

RECOMMENDS

that the Board of Trustees authorize the Chairman to ratify and execute a software licensing agreement with Imaginit Technologies, Schaumburg, IL for the various campuses listed above for the AutoCAD software at a total cost of \$28,025.00 for one-year period beginning December 31 2008 through December 30, 2009.
