that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

NEW PROPOSALS OR GRANTS (Total Value - \$800,472.43)

California Indian Manpower Consortium, Inc. (PD# 090303)

The California Indian Manpower Consortium, Inc has agreed to pay the tuition and training costs of project participants who enroll in programs at the City Colleges of Chicago. The performance period for this agreement is from January, 2009 until terminated by either party.

Energy Efficient Lighting Upgrade Grant (PD# 090304)

The District Office has submitted a proposal to the Illinois Clean Energy Community Foundation to help fund the upgrading of lighting fixtures to high lumen T-8 lamps using low power factor electronic ballasts. The grant request is for \$210,888 (which is a portion of the total project cost of \$616,485). The estimated reduction in power consumption is 351.48 kW. The facilities involved include Daley College, Humbolt Park Vocational Education Center, Lake View Learning Center, Olive-Harvey College, South Chicago Learning Center and Dawson Technical Institute. The project should be completed by December 31, 2009.

Introduction of Mass Spectrometry to the Chemistry Curriculum of the Chicago-area Community Colleges (PD# 090305)

Loyola University has received notification of funding from the National Science Foundation for a project which upgrade the chemistry curriculum, by utilizing mass spectrometry equipment, and evaluate the effectiveness of the new curriculum. The project involves a subcontract to Harold Washington College for \$59,079 (\$19,690 per year for three years). The performance period for this project is from January 1, 2009 through December 31, 2011.

After School Matters - Careers College Success Programs (PD# 090307)

Kennedy-King College has submitted a proposal for \$75,536 to the Chicago Department of Children and Youth Services to support pre-apprentice and apprentice programs in the areas of theatre design production, automotive and career development. The six week programs will offer hands-on experience for high school students. The performance period for this project is from June 22, 2009 through August 14, 2009.

Digital Divide (PD# 090308)

Kennedy-King College has submitted a proposal for \$79,969.43 to the Illinois Department of Commerce and Economic Opportunity for a project that would enhance technology opportunities for students through open lab access, basic skills training, job search and internet application, CTC networks and career education. The performance period for this project is from September 1, 2009 through August 30, 2010.

City Science (PD# 090309)

WYCC-TV20 has submitted a request for \$30,000 to the Field Foundation of Illinois, to fund two episodes of the City Science television series. The performance period for this project is from June 1, 2009 through March 30, 2010.

Teen REACH (PD# 090310)

Wright College has submitted a proposal for \$245,000 to the Illinois Department of Human Services for a Teen REACH project in collaboration with the Chicago Academy and Chicago Academy High School. Both of these schools are located at the former location of Wright College, 3400 North Austin Blvd. The project would provide after school and out-of-school activities for 75 children on a daily average so as to instances of negative behavior from unsupervised teenagers. The performance period for this project is from July 1, 2009 through June 30, 2010.

Greening Historic Uptown: Truman College Landscape Improvement (PD# 090311)

Truman College has submitted a request to Chalet Nursery for \$100,000 to install appropriate and sustainable landscaping on the Truman College Campus. The performance period for this project would be from June 1, 2009 through November 30, 2009.

CONTINUING AWARDS (Total Value - Additional \$43,404)

GEAR-UP EXTENSION (PD# 090301)

Northeastern Illinois University has awarded a continuation subcontract of an additional \$43,404 to Truman College to support efforts to better align standards from high school to college and to improve readiness for college. The project will provide services which increase the proportion of students who leave high school prepared for college. The performance period for this extension of the project is from Sept. 1, 2008 through August 31, 2009.

GIFTS (Total Value - \$305,191)

Batesville Casket (PD# 090302)

Malcolm X College has received a donation of promotional and marketing materials for use in its educational mortuary programs from Batesville Casket. The estimated value of the materials is \$8,141.

Mammography Equipment (PD# 090306)

The University of Chicago Medical Center is donating a used mammography system to Malcolm X College to be used for training purposes at the College. The equipment had an original purchase price of \$282,050 in 2002. The equipment will not be used at the College on human subjects and the College will assume all costs of transportation, installation and maintenance (if necessary).

Retail/Hospitality Bridge Program (PD# 090311)

Harold Washington College received a check for \$15,000 from Wal-Mart Stores, Inc. to be used for the Retail/Hospitality Bridge Program which offers training to students who are interested in careers in retail, restaurant and hotel industries.

THE CHANCELLOR

RECOMMENDS that the Board of Trustees approve acceptance of any gifts, grants or other funding which may be forthcoming from these proposals and authorize the Chancellor, the Vice Chancellor for Academic Affairs, or the District Director for Grants and Contracts to serve as *authorized representative* or *official representative* of the District in the submission of proposals for funding and to execute all documents for the acceptance of this funding or these gifts and the operation of the funded projects; said acceptance to be subject to the terms and conditions set forth by the grantor, and said funds not to be expended by the Board for any other purposes.
