NEW PROPOSALS (Total Amount Proposed \$405,000)

RE1-Hope and Healing: Rethinking Race (PD# 100410)

WYCC-TV has submitted a proposal for \$300,000 to the Kellogg Foundation to support a project which would engage viewers in meaningful and substantive conversations about how race impacts us - in the past, present and future. The performance period for this project is from January 1, 2010 through December 30, 2011.

Nursing Supports Project (PD# 100408)

The District Office has submitted a proposal to the Chicago Department of Family and Support Services for \$105,000 to provide academic and financial support for first year and second year nursing students. The performance period for this award is from July 1, 2009 through December 31, 2010.

NEW AWARDS (Total Amount Received \$670,643.87)

Fiscal Stabilization Award (PD# 100401)

WYCC-TV has received funding of \$68,680.27 from the Corporation for Public Broadcasting. This grant supports the basic operation of WYCC-TV and the funds are considered unrestricted in that they are to be used "to maintain local programming and services and preserve jobs threatened by declines in non-federal revenue sources during the current economic decline." There is no expenditure period for the funding.

The Ounce of Prevention Fund (PD# 100402)

The Ounce of Prevention Fund has awarded \$21,600 to Harold Washington College to pay the cost of providing training to six staff

members from the Centers for New Horizons towards a CDA - Infants and Toddlers Certificate. The performance period for this project is from January 1, 2010 through June 30, 2010.

The Ounce of Prevention Fund (PD# 100404)

The Ounce of Prevention Fund has awarded \$75,421.60 to Harold Washington College to pay the cost of providing training to 20 Early Head Start staff members towards a CDA - Infants and Toddlers Certificate. The performance period for this project is from March 1, 2010 through September 29, 2010.

Interconnection Grant (PD# 100405)

WYCC-TV has received notification of funding of \$15,864 for the Interconnection Grant from the Corporation for Public Broadcasting. This grant supports the basic operation of WYCC-TV and the performance period for the grant project is from October 1, 2009 until September 30, 2010.

GLISTEN (PD# 100403)

Harold Washington College has received a subaward of \$45,000 from the National Center for Science and Civic Engagement as part of the Chicago Great Lakes Collaborative. The project will encourage and support students in science and engineering pathways to transfer to local universities and complete college degree programs. The project will incorporate Great Lakes environmental challenges into course curriculum. The performance period for the first year of this project is from January 1, 2010 through December 31, 2010.

Chicago's Healthcare Careers Pathways Partnership (PD# 100406)

The National Council of La Raza (NCLR) has received an award from the US Department of Labor and is issuing a subcontract to Wright College for \$341,958 for the first year of a three project. The three year total will be \$1,025,874. The project provides tuition and training costs for students to enter healthcare career pathways. The performance period for the first year of the project is from March 1, 2010 through February 28, 2011.

Cooperative Work Study (PD# 100407)

Wright College has received funding of \$9,120 from the Illinois Board of Higher Education to support cooperative work study programs by paying a portion of the salaries that students earn while in their internship positions in business and industry. The performance period for this project is from January 26, 2010 until June 30, 2011.

Science Education for Civic Engagement (PD# 100409)

The National Center for Science and Civic Engagement has awarded a subcontract to Malcolm X College of \$3,000 to be used for faculty development and student learning opportunities in science education. The performance period for this project is from January 1, 2010 through January 31, 2012.

CIMA Technology Center (PD# 100411)

Wright College has received an award of \$50,000 from the Illinois Community College Board for a program that will provide internships and training programs in A+ Certification (computer repair and troubleshooting) and CompTIA Network + Certification. The performance period for this project is from January 1, 2010 through June 30, 2010.

Nursing Program of Study - Daley College (PD# 100412)

Daley College has received a Nursing Program of Study award of \$20,000 from the Illinois Community College Board. The grant will focus on improving student transition results for the Nursing program. The performance period for this award is from February 1, 2010 through June 30, 2010.

Nursing Program of Study - Truman College (PD# 100413)

Truman College has received a Nursing Program of Study award of \$20,000 from the Illinois Community College Board. The grant will focus on improving student transition results for the Nursing program. The performance period for this award is from February 1, 2010 through June 30, 2010.

GIFTS AND DONATIONS (Estimated Value \$4,122)

Washburne Culinary Fundraising Dinner (PD# 100414)

Partytime Productions, Inc., of Addison, Illinois, is donating entrance marquees, red carpeting and other party supplies, with an estimated value of \$4,122, to be used by Kennedy-King College for the Washburne Culinary Institute Fundraising Dinner.
