THE CHANCELLOR

that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

NEW PROPOSALS (Total Amount Proposed \$ 363,140)

Middle School Partnership for Out of School Time (PD# 100801)

Harold Washington College has submitted a proposal for \$288,140 to the National Science Foundation.

Benefit to the City Colleges of Chicago: This funding will allow the City Colleges of Chicago to form a partnership with the Chicago Public Schools and local universities to explore the use of after school or out of school activities for middle school (grades 5 - 8) students in the STEM fields (Science, Technology, Engineering and Mathematics). The partnership will plan activities, share resources and create an assessment tool.

Accountability: Professor Michael Davis, from the Physical Science Department at Harold Washington College will be the Principal Investigator for the project and will have all fiscal and programmatic responsibility for its operation.

Other Information: The performance period for this project is from June 1, 2011 through May 30, 2013.

Early School Leaver Transition Program (PD# 100802)

The District Office has submitted a request for \$75,000 to the Illinois Community College Board for the Early School Leavers Program.

Benefit to the City Colleges of Chicago: This funding will allow the District to help young people overcome academic, vocational and career readiness limitations through programs which transition students to

employment or community college post-secondary education training programs and provide support for youth (ages 16-21) who have not completed high school.

Accountability: Dr. Lizzette Richardson, Associate Vice Chancellor for Adult Education, will serve as the Project Administrator and will have overall responsibility for the financial and programmatic operation of the project. Ms. Lynette Stokes, Dean of Adult Education at Malcolm X College will serve as Project Coordinator and will have responsibility for the day to day operation of the project.

Other Information: The proposal requests funding for one program serving 35 students to be housed at Malcolm X College.

CONTINUATION AWARDS (Total Amount Received (\$99,092))

Teen REACH (PD# 090310 - YR2)

Wright College has received continuation funding of \$99,092, from the Illinois Department of Human Services for a Teen REACH project.

Benefit to the City Colleges of Chicago: This funding will allow the District to provide after school and out-of-school activities for 75 children on a daily average so as to reduce instances of negative behavior from unsupervised teenagers.

Accountability: Ms. Tina Gulley-Augustus, Program Coordinator, Wilbur Wright College, will be the Project Director and will have both programmatic and budget responsibility under the supervision of Dr. Cynthia Cordes, Vice President of Wright College.

Other Information: Wright College will operate this project in collaboration with the Chicago Academy and Chicago Academy High School. Both of these schools are located at the former location of Wright College, 3400 North Austin Blvd. The performance period for the second year of this project is from July 1, 2010 through June 30, 2011.

AMENDMENTS

Summer Programs Food Services (PD# 100532)

The District had requested an allocation of \$105,000 from the Illinois State Board of Education. *The actual award now provides \$123,683 for summer food programs.*

Benefit to the City Colleges of Chicago: This award provides funding for summer food programs.

Accountability: Ms. Jasmika Cook, Associate Vice Chancellor for Workforce Development.

Other Information: The District's approved vendor for cafeteria and vending services, the Compass Group, will be utilized to provide lunch and snacks for program participants. The performance period for this funded project is from June 16, 2010 through August 31, 2010.

that the Board of Trustees approve acceptance of any gifts, grants or other funding which may be forthcoming from these proposals and authorize the Chancellor, the Vice Chancellor for Development, or the District Director for Grants and Contracts to serve as *authorized representative* or *official representative* of the District in the submission of proposals for funding and to execute all documents for the acceptance of this funding or these gifts and the operation of the funded projects; said acceptance to be subject to the terms and conditions set forth by the grantor, including specified subcontracts and purchases, and said funds not to be expended by the Board for any other purposes.
