**NEW PROPOSALS (Total Amount Proposed \$989,000)****Nursing School Improvement Grant (PD# 101205)**

The City Colleges has submitted a request for \$44,000 to the Illinois Board of Higher Education.

**Benefit to the City Colleges of Chicago:** This funding will allow the District to support expanded NCLEX-RN programs at Daley College and provide equipment and support services to improve retention and exam pass rates.

**Accountability:** Ms. Benita Hunter, Dean of Career Programs at Daley College will be responsible for all fiscal and programmatic aspects of the project.

**Other Information:** The performance period for this project is from July 1, 2011 through June 30, 2012.

**FDC Foundation (PD# 101206)**

Wilbur Wright College has submitted a request for \$15,000 to the FDC Foundation.

**Benefit to the City Colleges of Chicago:** This funding will allow the District to promote a youth wellness and gardening program at the Chicago Academy Campus Community School (the old Wilbur Wright South building).

**Accountability:** Ms. Tina Gulley-Augustus, Program Coordinator for the Community School Partnership of Wilbur Wright College will supervise the activities of this project and will be responsible for all fiscal and programmatic aspects of the project.

**Other Information:** The performance period for this project is from January 1, 2011 through December 31, 2011.

**Building Workforce Skills of Community College Students Through Undergraduate Research (PD# 101207)**

The District has submitted a proposal to the National Science Foundation for \$900,000 to fund a three year project supporting undergraduate research participation.

**Benefit to the City Colleges of Chicago:** This project will provide an undergraduate research experience for 35 community college students during each year of funding. These students will participate in an academic year program where they will be mentored by community college STEM faculty, enrolled in a formal research course that addresses the 4C skills required by the 21st century workforce, and become part of a scientific learning community led by students. As part of the learning community, students will practice their workforce skills in a supportive atmosphere that develops their confidence, network with students and faculty from our four year college partners, and meet members of the Chicagoland business community. During the summer, students will either participate in a one week research intensive, skills building boot camp at Dominican University, or do 10-week, full-time, REU-like research with one of our four-year partner institutions: Chicago State University, Illinois State University, Youngstown State University, or Hope College.

**Accountability:** Dr. Thomas Higgins, Chairperson of the Physical Science Department at Harold Washington College, will be the Principal Investigator for this project and will be responsible for all fiscal and programmatic aspects of the project.

**Other Information:** The performance period for this project is from October 1, 2011 through September 30, 2014.

**Cooperative Work Study (PD# 101208)**

Wright College has submitted a proposal to the Illinois Board of Higher Education for \$30,000.

**Benefit to the City Colleges of Chicago:** This funding will allow the District to provide paid internships for students enrolled in technical programs.

**Accountability:** Ms. Madeline Roman-Vargas, Dean of the Humboldt Park Vocational Education Center, will serve as the Project Director and will be responsible for all fiscal and programmatic aspects of the project.

**Other Information:** The performance period for this project is from February 15, 2011 through June 30, 2012.

**CONTINUATION AWARDS (Total Amount Received \$1,248,420)**

**Head Start/Collaboration Grant(PD# 101202)**

The City of Chicago, Department of Family and Support Services, has awarded \$1,173,299 to the District.

**Benefit to the City Colleges of Chicago:** This funding will allow the District to support child care programs throughout the District.

**Accountability:** Dr. Jan Stepto Millett, District Director for Child Development Studies, will be responsible for all fiscal and programmatic aspects of the project.

**Other Information:** The performance period for this project is from December 1, 2010 through November 30, 2011.

**Career and Technical Innovation Grant (PD# 101210)**

The Illinois Community College Board has made FY 2011 allocations for the CTE Innovations Grant. The funding for the City Colleges of Chicago will total \$75,121.

**Benefit to the City Colleges of Chicago:** This funding will allow the District to help develop or enhance innovative community college career and technical education programs.

**Accountability:** Dr. Jasmika Cook, Associate Vice Chancellor for Workforce Development, will be responsible for all fiscal and programmatic aspects of the project.

**Other Information:** The allocations, based on CTE enrollments and using both federal and state funding, provide the following funding: Daley (\$11,974), Kennedy-King (\$13,339) Malcolm X (\$4,899), Olive-Harvey (\$4,228), Truman (\$4,708), Washington (\$29,685) and Wright (\$6,288). The performance period for the project is from December 1, 2010 through November 30, 2011.

**AMENDMENTS (Valued at \$101,764)**

**Carl D. Perkins, Title III (PD# 100516)**

The City Colleges of Chicago has received a preliminary grant allocation under the federal Carl D. Perkins Title III program of \$3,901,789 from the Illinois Community College Board.

**Benefit to the City Colleges of Chicago:** utilizing funds from the U.S. Department of Education, this project is designed to improve student performance in career and technical education programs as measured by a set of core indicators specified in the local plan guidelines.

**Accountability:** Ms. Jasmika Cook, Associate Vice Chancellor for Workforce Development.

**Other Information:** The performance period for this project is from July, 2010 to June 30, 2011. *The Illinois Community College Board has now released of an additional \$400,000 in federal Perkins funds for fiscal year 2011. The City Colleges of Chicago has been allocated an additional \$101,764 from the \$400,000 for FY 2011 Perkins.*

**GIFTS OR DONATIONS (Valued at \$99,500)**

**2002 Ford E350 Ambulance (PD#101201)**

1<sup>st</sup> Response EMS, INC. is donating a 2002 Ford E350 Ambulance to Olive-Harvey College for use in the college's Emergency Management Systems Program. The estimated value of the vehicle is \$8,500.

**IBM Green Initiatives Support (PD# 101203)**

Kennedy-King College received three IBM computer servers and a \$10,000 cash donation to support their Green Week program. The total value of the prospective donation is \$16,000.

**David and Jean Stremmel Fund (PD# 101204)**

The David and Jean Stremmel Fund has made a donation of \$2,000 to WYCC TV20. This donation will be deposited into the CCC Foundation on behalf of WYCC.

**Bucksqueeze Safety Belts (PD# 101209)**

Commonwealth Edison has donated five Bucksqueeze Safety Belts, valued at approximately \$3,000, to Dawson Technical Institute in support of the Overhead Electrical Line Workers program. The safety belts help prevent workers from falling from poles in the unlikely event of an accident.

**Illitron (Illinois Tool Works) 24'' Variable Involute Measuring Instrument (PD# 101211)**

Illitron (Illinois Tool Works) has donated a 24'' Variable Involute Measuring Instrument (PD# 101211) Model # 3424B, S/N 11015, with Electronic Recorder, model 1606-3, S/N 11373 to Daley College. The machine has an estimated value of \$70,000. With a measuring tolerance to within .000050 inches this type of involute gear measuring machine is still in use today. This particular machine was in use up until two years ago by the donor, Northstar Aerospace. The machine is an advantage pedagogically. The newest inspection technology is highly automated and students do not gain knowledge of gear quality from using it. The manual measuring instruments allow for teaching the art and science of gear manufacturing with a direct, hands-on approach. This is highly valued by AGMA and their member companies. This donation will allow Daley College to check much larger gears, such gears as our industry partners (Northstar, Arrow Gear, Brad Foote Gear, et al.) produce.
