THE CHANCELLOR

REPORTS

that there is a need to purchase health supplies for various Allied Health programs on an as needed basis throughout the District; and

that the District's Office of Business and Procurement Services has determined that it is most feasible and cost effective to utilize the following State of Illinois Central Management Services (CMS) contracted vendors: Gulf South Medical Supply-Ridgeland, MS, Kentron Health Care, Inc.-Springfield, TN; Medline Industries Inc.-Vernon Hills, IL; Moore Medical U C-Farmington, CT; Precision Medical Inc.-Tempe, AR; and

that these vendors were selected on a competitive basis through advertised Bid Specification #224659 and authorized by Contract No.'s 4016053, 4016054, 4016055, 4016056, 4076057 dated April 1, 2010 through March 31, 2011; and

that Procurement Services has requested approval to utilize services from the various State of Illinois CMS Hospital Supply vendors District-Wide on an as needed basis from June 3, 2010 through March 31, 2011, for a total amount not to exceed \$150,000; and

that contracts for goods and services procured from another governmental agency are exempt from the District's competitive bidding requirements; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced proposal to purchase hospital supplies from the various vendors utilizing the listing from the State of Illinois Office of Central Management Services, which reflects certified MBE and WBE firms in compliance with the goals detailed in bid specifications and, is therefore recommending a waiver of additional subcontractor requirements in compliance with the Board Approved Participation Plan.

RECOMMENDS

that the Board of Trustees approves the issuance of purchase orders to Gulf South Medical Supply-Ridgeland, MS, Kentron Health Care, Inc.-Springfield, TN; Medline Industries Inc.-Vernon Hills, IL; Moore Medical U C-Farmington, CT and Precision Medical Inc.-Tempe, AR in a combined amount not to exceed \$150,000 for staff to purchase Hospital Supplies District-Wide from June 3, 2010 through March 31, 2011.
