**REPORTS**

that in Fiscal Year 2009 Board Report # 28914 adopted August 7, 2008 granted approval to annually purchase database published online subscription services for libraries, legal research and instructional aids for various programs at all colleges from sole source database publishers; and

that the College libraries are expected to provide resources which support the curriculum and it is necessary to continue to provide the students with these resources; and

that based on previous usage, CCC staff recommends approval to purchase online subscription services annually beginning July 1, 2010 through June 30, 2011 which are procurable exclusively through the vendors listed below:
