**RESOLUTION TO SET TUITION, FEES AND CHARGES
FOR BOARD PROGRAMS**

WHEREAS, The Illinois Compiled Statutes (110 ILCS 805/3-45) authorize a Community College Board to require tuition; and

WHEREAS, Section 4.3.4 of the Rules for the Management and Government of the City Colleges of Chicago provide that the Board shall set tuition, fees and charges for all Board programs and establish policies for refunds and waivers of tuition, fees, and charges by Resolution; and

WHEREAS, The Board of Trustees in Board Report No. 29139 (February 5, 2009) has previously approved, adopted, and now seeks to amend such tuition and fees;

NOW THEREFORE, BE IT RESOLVED, That said amendments to the tuition and fees shall be effective as of the academic terms listed below.

A. Tuition (In-District)

B. (1) Out-of-District

Annually, the out-of-district tuition rate will be calculated as the sum of the current in-district tuition rate and the amount reported as Chargeback Reimbursement per Semester Credit Hour in the “Certification of Chargeback Reimbursement” incorporated in the previous fiscal year’s audited financial statements.

B. (2) Out-of-State

Annually, the out-of-state tuition rate will be calculated as the sum of the current in-district tuition rate and the amount resulting from dividing the Total Qualified Expenditures reports in the “Certification of Chargeback Reimbursement” incorporated in the previous fiscal year’s audited financial statements by the Total Certified Semester Credit Hours reported in the same and subtracting the tuition rate in effect in that fiscal year.

C. Registration Fees (Non-Refundable)

- current \$25.00 to \$30.00 beginning Summer 2010

D. Activity Fee

- current: \$150.00 for Full-time regular term to \$170.00 beginning Fall 2010
- current: \$75.00 for Full time summer term to \$85.00 beginning Summer 2011
- no change from current \$50.00 for Part-time

E. Course Fees

- Fees are based on course requirements, such as materials and supplies, and such fees will be published in the class schedules.
