ADDITIONAL FUNDS REQUEST
(AMEND BOARD REPORT 30273, ADOPTED MAY 12, 2010 AND
BOARD REPORT 29673, ADOPTED AUGUST 6, 2009)**

THE CHANCELLOR

REPORTS

that in Board Report 30273 adopted May 12, 2010, the Board authorized the Chairman to exercise the one year extension option with Bryden Transportation, LLC-Chicago, IL to provide shuttle bus transportation services to transport students and employees to and from Truman College to remote parking locations until the parking lot renovations for Truman College have been completed; and

that Bryden Transportation, LLC has agreed to continue to provide shuttle bus transportation services on behalf of Truman College under the same terms and conditions and that under the Board approved first option to renew the contract for one (1) additional year, the weekday, Monday thru Friday, hourly rate is \$35.28 per bus and the weekend, Saturday thru Sunday, hourly rate is \$35.28 per bus from July 1, 2010 through June 30, 2011, with the provision for termination for convenience at any time; and

that parking lot renovations were scheduled to be completed by September 2010 and due to the delay in completion of the project, Truman College is requesting that Board Report 30273 be amended to include additional funds in the amount of \$90,000 to be allocated to Bryden Transportation, LLC in order to cover the continued use of the service until the parking lot renovations for Truman College have been completed; and

that the Office of M/WBE Contract Compliance has reviewed the above request for an additional funds allocation to Bryden Transportation, LLC-Chicago IL, a certified MBE subcontracting with Princess Transportation, a certified WBE and requests that Bryden Transportation, LLC remains in compliance with the Board Approved Participation Plan; and

that it shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article II, Section 2.6.4(b) of the Board Rules for Management and Government.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees approves the additional funds allocation to Bryden Transportation, LLC-Chicago, IL for shuttle bus transportation services to Truman College under the same terms and conditions in an amount not to exceed \$90,000 from November 4, 2010 through June 30, 2011 with the provision for termination for convenience at any time.
