REPORTS

that the Community College Survey of Student Engagement, administered by the Center for Community College Student Engagement (CCCSE), is an assessment tool used nationally that provides information on student engagement and surveys institutional practices and student behaviors that are correlated highly with student learning and student retention; and

that as part of on-going efforts to promote and assess educational practices and student behaviors that relate to retention and student engagement in the college community and the community at large, the City Colleges of Chicago will survey a random sample of students enrolled in credit courses and all full and part-time credit faculty using the Community College Survey of Student Engagement (CCSSE) and the Community College Faculty Survey of Student Engagement (CCFSSE); and

that survey activities related to students and faculty will take place in Spring 2011 between mid-term and spring break; and

that the registration deadline for participation in both the CCSSE and CCFSSE is November 1, 2010 and that the estimated costs for surveys and administration are listed below:
