#### **REPORTS**

that in Board Report #29760, dated October 5, 2009, the Board of Trustees renewed three annual agreements with the Oracle Corporation for software support maintenance services on the following: 1)PeopleSoft Human Resource, Student Administration and Financial system core modules; 2) the PeopleSoft Contributor Relations and Portal modules; and 3) the PeopleSoft User Productivity Kit module; and

that the Oracle America Corporation has proposed to provide the necessary software updates and maintenance services on the above software modules and the terms and costs are the follows:

that OIT staff has determined that the proposals from Oracle which include a cost increase of three percent from the previous year are acceptable, and recommends renewal of the software support and maintenance service agreements for the periods indicated above; and

that this procurement of software maintenance services is exempt from the District's competitive bidding requirements; and

that the Office of M/WBE Contract Compliance has reviewed the above request for license renewals and, as there is no opportunity to subcontract licensing for direct participation, Oracle continues to provide contractual support to certified MBE and WBE firms through indirect participation in compliance with the Board Approved Participation Plan; and

that it shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article II, Section 2.6.4(b) of the Board Rules for Management and Government.

#### **RECOMMENDS**

that the Board of Trustees authorizes the Chairman to approve the renewal of agreements for a total amount not to exceed \$828,987.67 with the Oracle America Corporation to provide software upgrades and maintenance services for the PeopleSoft Human Resource, Student Administration and Financial system modules beginning November 1, 2010 through October 31, 2011, for PeopleSoft Contributor Relations, Campus Directory Interface and Portal software from November 6, 2010 through November 5, 2011 and for the PeopleSoft User Productivity Kit modules from October 31, 2010 through October 30, 2011.
