that specifications were prepared by District Procurement staff, publicly advertised on July 23, 2010 and emailed to ten (10) companies. A pre-bid meeting was held on July 29, 2010 and three (3) bids were received from Contractors Acoustical Supply-Joliet, IL, Specialty Products & Insulation-Itasca, IL and Just Rite Acoustics-Elk Grove, IL as listed below:

that Administrative Services has determined that it is in the best interest of City Colleges of Chicago to award the work based on the lowest responsive and responsible bidder's total bid price submitted by Contractors Acoustical Supply-Joliet, IL and has determined that its price is reasonable and acceptable; and

that the Office of M/WBE Contract Compliance has reviewed the above bid and Contractors Acoustical Supply, a direct supplier only of the requested tile, and purchasing fuel for delivery of the tile from West Fuels, a certified WBE, has requested a waiver of MBE participation, in compliance with the Board Approved Participation Plan.

**RECOMMENDS** that the Board of Trustees approves the issuance of a purchase order to Contractors
