THE CHANCELLOR

REPORTS

that it is necessary to provide service for winter snow removal to plow snow, clear walkways, salt areas, and haul away snow if necessary for all Colleges and Auxiliary Facilities; and

that in Board Report #28436 adopted December 6, 2007 the Board authorized the issuance of purchase orders to five companies selected by competitive bidding for an amount not to exceed \$70,000.00 per main campus assigned and \$35,000.00 per auxiliary campus assigned annually effective November 6, 2007 through November 6, 2010, in accordance with specification # SC0732 dated October 12, 2007; and

that the Office of Administrative Services is requesting approval to exercise the option to extend the agreement with four of the same vendors for a two year period at the same terms and conditions; and

that the following low responsible and responsive bids were reviewed and the following awards were given based on the lowest average hourly rate based quote for a typical snow plow truck, apparatus, and driver whereby the colleges may contact the vendor that is available to provide service for the requested period; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced snow removal vendors and determined that AGAE Contracting is subcontracting to Acer Enterprising as the WBE and Galaxy Environmental as the MBE; and American Parking Lot is subcontracting to Christy Weber as the WBE and F & B Construction and Alvarez Inc as the MBEs; and Tim’s Snow Plowing is subcontracting to King Construction as the WBE and First West Venture as the MBE; and Speedy Gonzalez, an MBE is subcontracting to King Construction as the WBE remain in compliance with the Board Approved Participation Plan.

THE CHANCELLOR

RECOMMENDS that the Board authorizes the issuance of purchase orders to the above listed companies for an amount not to exceed \$70,000.00 per main campus assigned and \$35,000.00 per auxiliary campus assigned annually effective November 6, 2010 through November 6, 2012, in accordance with specification # SC0732 dated October 12, 2007.
