The term of the agreement will commence on or around December 15, 2011 and end exactly one (1) year later on December 14, 2012, with an option to renew for an additional year from on or around December 15, 2012 through December 14, 2013.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff and publicly advertised on August 29, 2011 as Request for Proposal (RFP) SH1106–Information Technology (IT) Research and Advisory Subscription Services. Said RFP was sent to 14 firms and a pre-proposal conference was conducted on September 7, 2011. Submittals were received on September 22, 2011 from one (1) vendor: Gartner Inc.

The firms were evaluated according to the following criteria:

- 1. Proposed plan of action for the execution of the requested scope of services;
- 2. Past Experience in providing similar services with educational institutions, government agencies or private firms;
- 3. Fees in relation to the Scope of Services; and
- 4. M/WBE Compliance Plan

Forrester Research Inc. was deemed nonresponsive for failure to comply with formatting requirements and failure to meet the submission deadline.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above referenced agreement option and, Gartner, providing direct technical services as required with no ability to provide additional subcontracting opportunities to certified M/WBE firms, is recommending a waiver of direct participation in compliance with the Board Approved Participation Plan.
