BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Academic Affairs has determined that it is more cost effective to utilize the above listed vendors to support online subscription services for libraries, legal research and instructional aides

for various programs at all colleges.

VENDOR SELECTION CRITERIA:

The online subscriptions services and instructional aides are only available through sole source data

publishers approved vendors. Pursuant to State law, purchases that are economically procurable

from a sole source are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above referenced listing of sole source

vendors and, as there is no opportunity to further directly subcontract the online services provided by these vendors, it is recommended that a waiver of direct compliance with the Board Approved

Participation Plan be approved.
