THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chairman to execute a five (5) year District-wide service contract with AT&T Corporation to provide a scalable optical network service to 11 S. LaSalle, Chicago, Illinois for the period from June 1, 2011 through June 30, 2014, at a monthly cost of \$1,314.00 for a total annual cost of \$47,304.00

TERM:

The term of the agreement will commence on June 1, 2011 and end on June 30, 2014.

SCOPE OF SERVICES:

AT&T will provide a fully managed data circuit that will connect 11 S. LaSalle to the City Colleges of Chicago network and will provide up to 20Mbps of bandwidth for internet and enterprise services connectivity such as email, PeopleSoft applications, and file sharing.

BENEFIT TO CITY COLLEGES OF CHICAGO:

This solution will provide the District with an OPT-E-MAN circuit that will connect 11 S. LaSalle, Chicago, Illinois location to the City Colleges of Chicago data network. This connectivity is identical to what is used at the satellite campuses, and it is a reliable, secure and cost-effective solution to ensure that the District's different office locations can connect to the same network.

DELIVERABLES:

AT&T will perform as follows:

1. Provision of one (1) 20 Mbps OPT-E-MAN circuit at 11 S. LaSalle, Chicago, Illinois
2. Installation of all associated AT&T owned equipment at 11 S. LaSalle, Chicago, Illinois

VENDOR SELECTION CRITERIA:

Pursuant to Section 1.07(F) of the City Colleges of Chicago Board Operations Manual, purchases and contracts for the use, purchase, delivery, movement or installation of telecommunications and inter-connect equipment, software and services are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above agreement request and has determined that AT&T, through indirect participation, is in compliance with the Board Approved Participation Plan.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

FINANCIAL:

AT&T shall be paid as set forth in the agreement; at monthly cost of \$1,314.00 for a total cost not to exceed \$47,304.00 for the contract term.
