SUMMARY OF AGREEMENT

Brett's Broadcast Consulting, LLC

Consultant will provide software maintenance and technical support on WYCC's automation software VCI Solutions.

SCOPE OF SERVICES

Statmon Technologies

The Consultant will provide the following services:

- Maintenance of software required for monitoring and controlling the transmitter at the John Hancock building.
