#### THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chairman to execute an agreement with Goettsch Partners to prepare plans and specifications to be utilized for estimating and published for open public bid the construction of a new metal roof on the Wright College Learning Resource Center at a total cost not to exceed \$640,000.

#### TERM:

The term of the agreement will begin in November, 2011 until the later of the date of completion of the construction of the projects covered in the drawings or December 31, 2012.

#### **SCOPE OF SERVICES:**

Goettsch Partners will provide engineering design, consultation and planning documents for replacement and upgrades of structural systems of the existing metal roof structure as described below and prepare bid documents and construction administration as required.

- 1. Present design options for replacement of existing standing seam roof system.
- 2. Design new replacement roof with consideration of original design intent of Bertrand Goldberg.
- 3. Refurbish / restore / reconstruct the atrium skylight and penetrations.
- 4. Re-design / re-engineer existing window skylights and air intake / exhaust unit penetrations.
- 5. Refurbish / restore lighting protection system.
- 6. Refurbish / restore ice melting system.
- 7. Design / develop new fall arrest system.

The Office of Administrative and Procurement Services has negotiated the fee to be paid on the design portion of the approved architectural/ engineering services consistent with published Illinois Capital Development Board (CDB) Guidelines for projects of this nature based on an estimated construction budget of \$3,500,000.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The Office of Administrative and Procurement Services has reviewed this request for services and has determined that it would be in the best interest of the District to move forward with Goettsch Partners as the engineer of record on the planning and design of the replacement of existing metal roof at Wright College to allow its designs and plans as approved by the Office of Administrative Services, District IT and Wright College. The new system will enhance the life safety environment for staff, students and general public and reduce the maintenance cost dramatically. The present metal roof system at Wright College is in constant need of repairs and causing major concerns to electrical equipment in the building thus creating a life safety concern when it rains.
