THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chairman to execute an agreement with Scholastic, Inc. to provide the Olive-Harvey Middle College program with a computerized reading application that provides direct individualized instruction to struggling readers for the period beginning November 14, 2011 through June 15, 2012 at a total cost not to exceed \$29,200.

VENDOR: Scholastic, Inc.

USER: The Olive-Harvey Middle College Program

TERM:

The term of the agreement will begin on November 14, 2011 and end on June 15, 2012.

SCOPE OF SERVICES:

The Reading 180 Program addresses the unique needs of struggling readers by adapting instruction to meet individual student reading demands. The Reading 180 Program, offered by Scholastic Inc., includes student licenses and consumable workbooks to supplement instruction. The services will also include 30 licenses and 8 in classroom support visits. Through the Reading 180 Program model, Olive-Harvey Middle College will impart 100 instructional minutes daily to be taught by an Olive-Harvey Middle College Instructor who has earned a Master's degree in Reading and is equipped with experience teaching the Reading 180 Program.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Reading 180 Program provided by Scholastic Inc. will make available a proven instructional model that results in increased reading achievement gains after one to two years of participation. The Reading 180 Program directly correlates with the Illinois State Board of Education English/Language Arts Standards.

VENDOR SELECTION CRITERIA:

The contract being utilized as a part of the joint purchasing agreement has been advertised and

awarded in accordance with the procurement procedures of the Chicago Board of Education d/b/a Chicago Public Schools through a Request for Proposal # 10-250007 and awarded under Original Board Report # 10-0428-PR40-14, Amended Board Report #10-0922-PR22-14 and the First Option to Renew Board Report# 11-0727PR31. Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District's competitive bidding requirements. The Reading 180 Program has also been recommended by the grantor, Youth Connection Charter School.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above agreement and Scholastic, Inc., self-performing the functions on this project with no reasonable ability to subcontract to certified MBE or WBE firms, is recommending a waiver of compliance with the Board Approved Participation Plan.

GENERAL CONDITIONS:

Inspector General – It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article II, Section 2.6.4(b) of the Board Rules for Management and Government.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.
