LICENSE AGREEMENT TOOLING U, LLC WRIGHT COLLEGE (RATIFICATION)

THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chairman to approve a one year licensing agreement with Tooling U to provide software for 100 students to support the instruction in manufacturing related courses at the Humboldt Park Vocational Educational Center (HPVEC) of Wright College for the period from October 6, 2011 through September 30, 2012 at a total cost not to exceed \$25,600.

TERM:

The term of this agreement will commence on October 6, 2011 and will end on September 30, 2012.

SCOPE OF SERVICES:

Tooling U, LLC (Tooling U) will provide access to educational software used in the Computer Numerical Control and Electrical/Electronics Industrial Maintenance Programs for the delivery of the curriculum for students. One-hundred (100) software licenses at a cost of \$256 per license will be provided to students as part of their material fees associated with the programs.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Tooling U software provides students with a curriculum aligned with the National Institute of Manufacturing Standards (NIMS) certifications that are sought by local employers and promoted by the Chicago Manufacturing Renaissance Counsel. This educational software is also designed to be compatible with the machining equipment used for instruction at HPVEC. Completion of this curriculum equips students with the necessary knowledge to successfully earn NIMS Certifications which are embedded in the manufacturing courses.

DELIVERABLES:

Tooling U will deliver 100 one-year software licenses for use by students registered in manufacturing at the Humboldt Park Center and allow program administrators and faculty access to the Tooling U Learning Management System to track student progress throughout the program.

VENDOR SELECTION CRITERIA:

Pursuant to State law, purchases and contracts for the use, purchase, delivery, movement or installation software and services are exempt from the District's competitive bidding requirements.

M/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above referenced license agreement, and since Tooling U developed and owns the software to be used, and since there are no direct or indirect opportunities for certified MBE or WBE vendors to provide the requisite support for the software, it is recommended that a waiver from compliance with the Board Approved Participation Plan be granted.

GENERAL CONDITIONS:

Inspector General – It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article II, Section 2.6.4(b) of the Board Rules for Management and Government.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.
