TERM:

The term of this agreement shall commence on September 1, 2011 and shall end on June 30, 2012.

SCOPE OF SERVICES:

BBC Worldwide Americas, Inc. will provide WYCC-TV20 with programs that are exclusive in the Chicago broadcast market.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Selected programming will provide secondary PBS stations in overlap markets, similar to the Chicago situation between WYCC and WTTW, a strategically important opportunity to differentiate its schedule and grow audience and membership.

DELIVERABLES:

Programming and promotional support that is exclusive to WYCC-TV20 in the Chicago broadcast market.

VENDOR SELECTION CRITERIA:

Pursuant to State law, goods which are economically procurable from only one source are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of MBE/WBE Contract Compliance has reviewed the above referenced purchase and, there are no local certified MBE or WBE vendors that can provide syndicated television programs exclusive to WYCC and BBC Worldwide Americas, Inc. utilizing certified MBE and WBE vendors as indirect service providers outside of this project, is in compliance with the Board Approved Participation Plan.

GENERAL CONDITIONS:

Inspector General - It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article II, Section 2.6.4(b) of the Board Rules for Management and Government.

Ethics –It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.
