THE CHANCELLOR RECOMMENDS:

that the Board of Trustees approves the payment for contracted services, including ratification in the amount of \$10,612.12 for a total payment of \$11,022.16 for the annual renewal of the agreement with Associated Press News Service to provide AP Radio news services programming for WKKC – FM Radio at Kennedy-King College.

TERM: The terms for the three services from Associated Press News Service are as follows:

AP Radio News – January 10, 2011 through January 9, 2012
AP NewsPower – July 7, 2010 through July 6, 2011
AP News Desk - August 13, 2011 through August 12, 2012

SCOPE OF SERVICES:

Associated Press New Service will provide WKKC with continued access to news content, rights to broadcast news from around the world, training in news gathering and on-air news reporting for students enrolled in Kennedy-King College’s Media Communication Program.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Associated Press News Service will assist WKKC in providing breaking news coverage and the full breadth of international, national, state, prep and business news.

VENDOR SELECTION CRITERIA:

The agreement with Associated Press News Service is a sole source professional service agreement and is therefore is exempt from the District’s competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed above referenced agreement. As there are no opportunities for MBE or WBE subcontracting, it is recommended that a waiver from compliance with the Board Approved Participation Plan be approved.

GENERAL CONDITIONS:

Inspector General - It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General’s authority under Article II, Section 2.6.4(b) of the Board Rules for Management and Government.

Ethics - It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board’s Ethics Policy adopted January 7, 1993, and as amended by the Board.
