THE CHANCELLOR RECOMMENDS:

that the Board Trustees authorizes the Chair to execute an agreement with Compass Group USA, Inc. for the preparation and delivery of meals for the Child Development Laboratory Centers for the period from November 1, 2012 through October 3, 2013, at a total cost not to exceed \$265,146.

TERM:

The term of the agreement commenced on November 1, 2012 and will end on October 3, 2013 with an option to renew for an additional four (4) one (1) year periods.

SCOPE OF SERVICES:

Compass Group USA, Inc. shall prepare and deliver hot and cold family style meals daily for breakfast, lunch and supplement/snacks to the Child Development Laboratory Centers and comply with the Illinois State Board of Education – Child and Adult Food Program (CACFP) requirements. City Colleges of Chicago's Child Development Laboratory Centers at Truman College, Malcolm X College, Olive Harvey College, Daley College and the Child Care Center at Arturo Velasquez Institute are in need to contract for the following services:

BENEFIT TO CITY COLLEGES OF CHICAGO:

During the period in which City Colleges of Chicago was bidding for this service, Compass Group USA, Inc. continued to provide preparation and delivery of meals for the Child Development Laboratory Centers from October 1, 2012 through December 5, 2012, performed to the satisfaction of City Colleges of Chicago and adhered to the City's health and safety standards. Also, Compass Group USA, Inc. continues to provide the following items as part of the contract cost: 1) on location preparation of food; 2) staff that have a Food Service Certification; 3) utilization of the Compass kitchen that meets state requirements; 4) family style serving; and 5) staff who maintain and sanitize the kitchen.

DELIVERABLES:

Compass Group USA, Inc. shall prepare and deliver hot and cold family style meals daily for breakfast, lunch and supplement/snacks to the Child Development Laboratory Centers; the meals will meet the Head Start Performance Standards, Child and Adult Care Food Standards, and State of Illinois and City of Chicago Licensing requirements for children ages 3-5 years old.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement Staff and Sealed Bid #MWJ1209 was publicly advertised on September 7, 2012. Twelve (12) companies were contacted. Two (2) companies responded to the Bid on September 21, 2012; 1) Compass Group USA, Inc. and 2) Dee's Catering Service.

The bids were reviewed by staff from the State Board of Education (ISBE), the Offices of Academic Affairs, Business Enterprise and Administrative and Procurement Services. Dee's Catering Service was deemed non-responsive because it did not meet the MBE/WBE Compliance requirements. The evaluation committee recommends that the preparation and delivery of meals for the Child Development Laboratory Centers listed above be awarded to Compass Group USA, Inc.

The Office of M/WBE Contract Compliance has reviewed the above Agreement and Compass Group USA, Inc. is in compliance with the Board Approved Plan.

agreements authorized herein shall contain a clause that any expenditure beyond the current

fiscal year is subject to appropriation in the subsequent fiscal year.
