The term of this purchase shall commence on August 2, 2012 and shall end on June 30, 2013.

#### **SCOPE OF SERVICES:**

BBC Worldwide Americas, Inc. will provide WYCC-TV20 with programs that are exclusive in the Chicago broadcast market.

# **BENEFIT TO CITY COLLEGES OF CHICAGO:**

Selected programming will provide secondary PBS stations in overlap markets, similar to the Chicago situation between WYCC and WTTW, a strategically important opportunity to differentiate its schedule and grow audience and membership.

#### **VENDOR SELECTION CRITERIA:**

Pursuant to State law, goods which are economically procurable from only one source are exempt from the District's competitive bidding requirements.

# MBE/WBE COMPLIANCE:

The Office of MBE/WBE Contract Compliance has reviewed the above referenced purchase and, there are no local certified MBE or WBE vendors that can provide syndicated television programs exclusive to WYCC and BBC Worldwide Americas, Inc.
