THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chairman to execute an agreement with Oracle America, Inc. to provide 1,375 additional licenses for the Oracle Database Enterprise Edition, Diagnostics Pack and Tuning Pack products, supplemented by one year of support services, for the period from February 27, 2012 through February 26, 2013, at a total cost not to exceed \$192,912.50.

USER: District-wide

TERM:

Each of the licenses is perpetual, while the support services will begin on or around February 27, 2012 and end on or around February 26, 2013.

SCOPE OF SERVICES:

Oracle will provide City Colleges of Chicago (CCC) with 1,375 additional perpetual campus-wide Named User Plus licenses for Oracle Database Enterprise Edition, Diagnostics Pack and Tuning Pack (i.e., the Campus-Wide Programs) for a one-time fee of \$158,125.00, along with software maintenance support services for a fee of \$34,787.50, at a total cost of \$192,912.50.

BENEFIT TO CITY COLLEGES OF CHICAGO:

This solution will satisfy CCC's obligation to comply with Oracle's license policies and business practices, and authorize CCC to continue its deployment of Oracle database products in any configuration on an unlimited number of servers across the District's internet, intranet and client/server environment. Ready access to the Oracle system will provide 72,262 full-time and part-time CCC students, faculty and staff with reliable administrative and academic tools for meeting their school and work responsibilities to ensure student success. Maintenance services on the Oracle database will additionally provide an additional year of 24 x 7 support, upgrades on supported products and access to Oracle's resolution database.

VENDOR SELECTION CRITERIA:

Pursuant to State law, purchases and contracts for the use, purchase, delivery, movement or

installation software and services are exempt from the District's competitive bidding requirements.

The Office of M/WBE Contract Compliance has reviewed the above referenced agreement and there is no opportunity to subcontract for direct services for this project. However, Oracle does subcontract with certified MBE/WBE firms on other projects for indirect participation and therefore is in compliance with the Board Approved Participation Plan.
