BENEFIT TO CITY COLLEGES OF CHICAGO:

These agreements will provide the District with the technical expertise and experience necessary to support continued improvements and maintenance of Oracle/PeopleSoft software and other strategic technology initiatives for both short and long-term engagements. Additionally, these agreements will allow the District to continue to reduce spend on technical Professional Services. Over a 3 year period, Professional Services spend has been reduced by 75%.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff and publicly advertised on October 15, 2011 as Request for Proposal (RFP) SH1108 – Technical Staff Augmentation Services. Said RFP was sent to 21 firms and a pre-proposal conference was conducted on October 19, 2011. Submittals were received on October 28, 2011 from fourteen (14) vendors: 1) Aptude Inc.; 2) Bourntec; 3) Clarity Partners; 4) Expertise IT; 5) Inirus LLC; 6) Next Generation; 7) Oxford Global Resources; 8) SDA Consulting, Inc.; 9) Senryo Technologies; 10) Smart ERP Solutions Inc.; 11) Sofbang Inc.; 12) Solomons International, Inc.; 13) Synch Solutions; and 13) TEKsystems. The firms were evaluated according to the following criteria:

1. Relevant Staff Augmentation Experience
2. Quality of resources available
3. Availability of resources
4. Fees in relation to the Scope of Services
5. M/WBE Compliance Plan

The evaluation team recommended Bourntec, Next Generation and Senryo based on their oral presentations and combined overall evaluation scores.
