**TERM:**

The term of each agreement will commence on July 1, 2012 and end on June 30, 2013.

**SCOPE OF SERVICES:**

Oracle will provide software support maintenance services to the District for various Oracle modules as follows:

1. Provide maintenance and support services for Oracle Database Enterprise Edition software and related modules (Contract Number 1821612 in association with the 2003 Oracle License and Services Agreement);
2. Provide maintenance and support services for PeopleSoft Enterprise Talent Acquisition Management software and related modules (Contract Number 2774071 in association with the 2006 Oracle License and Services Agreement);
3. Provide maintenance and support services for Oracle Partitioning which enhances the performance, manageability and availability of a wide variety of applications and helps reduce costs for storing large amounts of data (Contract Number 3650674 in association with the 2003 Oracle License and Services Agreement);

4. Provide maintenance and support services for PeopleSoft Enterprise Portal (Contract Number 3666872 in association with the 1998 Software License and Services Agreement);
5. Provide maintenance and support services for PeopleSoft Enterprise Billing, Receivables and Grants – Nonstandard User Perpetual (Contract Number 3666638 in association with the 1998 Software License and Services Agreement);
6. Provide maintenance and support services for Micro Focus Server Express 2.X Upgrade (Contract Number P-03-01240-000—4 in association with the Acquired PSFT Agreement); and
7. Provide maintenance and support services for PeopleSoft Enterprise Billing, Receivables and Grants – Reported Budget Perpetual (Contract Number 4569179 in association with the 1998 Software License and Services Agreement).

**BENEFIT TO CITY COLLEGES OF CHICAGO:**

This solution will enable the District office to fulfill software upgrade and maintenance needs in a cost effective fashion.

Pursuant to State Law, all contracts for the purchase and delivery of data processing equipment, software and services are exempt from the District’s competitive bidding requirements.

**MBE/WBE COMPLIANCE:**

The Office of M/WBE Contract Compliance has reviewed the above referenced software support and maintenance service agreements, and as there are no certified MBE or WBE vendors who can directly provide the software updates and maintenance services needed to run the District’s PeopleSoft applications, Oracle does work with certified MBE and WBE firms as part of its commitment to diversity utilization (firms are detailed and on file) through indirect participation, and therefore, is in compliance with the Board Approved Participation Plan.

Inspector General – It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General’s authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable Provisions of the Board’s Ethics Policy adopted January 7, 1993, and as amended by the Board.
