RESOLUTION

ADOPTING RECOMMENDATIONS FOR VENDOR DEBARMENT

WHEREAS, pursuant to Section 5.3.8 of the City Colleges of Chicago Debarment Policy adopted on April 7, 2011, the Chief Procurement Officer for the Office of Administrative and Procurement Services has the authority to recommend debarment for vendors that conduct business with City Colleges of Chicago;

WHEREAS, the Vendors proposed for debarment received Notices of Proposed Debarment detailing the reasons for debarment and providing Vendors with 28 days to respond to or protest the debarment;

WHEREAS, one (1) Vendor filed an untimely protest and all other Vendors either failed to respond or voluntarily agreed to the debarment; therefore, the allegations set forth in all Notices of Proposed Debarment are deemed admitted;

WHEREAS, following recommendations made by the District Director of Procurement Services, the Chief Procurement Officer has concurred with all findings of debarment and requests that the Board proceed with debarment for the following Vendors;
