**TERM:**

The term will commence on March 1, 2012 and shall end February 28, 2014.

**SCOPE OF SERVICES:**

The above listed vendors will provide integrated pest management services to all City Colleges Facilities as required and will also respond to emergency pest containment and removal services to ensure a safe and healthy educational environment for students, faculty and staff.

**BENEFIT TO CITY COLLEGES:**

The Office of Administrative Services staff has determined that it is more feasible and cost effective to utilize Chicago Public Schools (CPS) contracted vendors approved through its bid and award for pest management services on an as needed basis to provide accessible access to a pool of vendors for pest

management services.

**VENDOR SELECTION CRITERIA:**

The contract being utilized as a part of the joint purchasing agreement has been advertised and awarded in accordance with the procurement procedures as detailed in Bid Solicitation # 09-250081, dated October 21, 2009, and approved under Chicago Public School Board Report #12-0125-PR5 dated January 25, 2012. Pursuant to State law, contracts for goods and services procured from another governmental agency are exempt from the District’s competitive bidding requirements.
