#### **SCOPE OF SERVICES:**

MasterGraphics, Inc. will provide the AutoCad/AutoDesk software for the Credit and Continuing Education comport aided design training programs at varies Colleges, as well as extend software license agreements that have expired at the Colleges. The scope of deliverables in addition include providing students with the ability to download three (3) year versions of the software for use on their home computers.

### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The computer software design suites will provide aided training, as well as resources to City Colleges of Chicago (CCC) students to further augment, enhance and complete their training and studies.

#### **VENDOR SELECTION CRITERIA:**

MasterGraphics was selected based upon its competitive pricing and scope of deliverables which include providing students with the ability to

download three (3) year versions of software for use on their home computers.

The Office of MBE/WBE Contract Compliance has reviewed the above referenced software license agreement with MasterGraphics, Inc. and as there are no certified MBE or WBE subcontracting opportunities, and or other vendors that could provide the product used by the District, it is recommended that the waiver of direct participation be continued in compliance with the Board Approved Participation Plan.
