The Office of Academic Affairs has determined that it is more cost-effective to utilize the above listed certified distributors from the American Heart Association to support the community training CPR courses and the health science programs which require that all students have CPR certification for clinical site participation.

VENDOR SELECTION CRITERIA:

The CPR materials and course completion cards are regulated and only available through the American Heart Association approved vendors and therefore procured economically from limited

resources and are exempt from the District's competitive bidding requirements.
